- Annual Operating Budget of over \$256k
- Annual Income/Revenue averages \$279k

FY18 Actuals Discussion

FY18 Income = \$282,748 FY18 Expenses = \$264,554 FY18 Balance = \$18,194

- Questions on legal expenses around pool incident
- President explained differences between month expense and \$25K retainer

#### 2019 Dues Increase

•

- Outsourcing increase with estimate of \$30K in costs
- Historical Dues Increases
  - Only 4 times since 2005
  - o 5th increase proposal \$400 to \$500
  - Proposal for associate dues increase \$515 to \$525
  - Combined 2019 dues increases will net approximately \$33K
- Discussion on why a dues increase is needed
- No objections from Homeowners
- Question on invoicing timing
  - o Invoices previously went out in Feb/March to align with our Fiscal Calendar
  - Moved to January two years ago to align with Fiscal Calendar change [now on calendar year]
  - $\circ$   $\quad$  Late fees will apply to both Homeowners and Assoc Members

# July

- All Employees are reimbursed for ambulance, hosp & medical
- Non Employees working directly with Esbro on reimbursement
- Criminal charges filed by DA against Esbro and employee

# October

- SB Insurance Carrier inspects facility [not related to incident]
- Esbro Chemical & individuals convicted by plea of misdemeanor violation of Health and Safety Code 42400.1
- Negligent emission of an air contaminant
